



MARES TRANSPORT & ARRIVAL AT HARAS DE BOUQUETOT

2020 CLIENTS PROTOCOL

Haras de Bouquetot, 1st stallion station to adopt a biosecurity plan in France

In the current context of fight against the spreading of virus Covid-19 and in the aim to minimize the contacts and risks for our collaborators and our team, Haras de Bouquetot (referred herein as “the Haras”) has established a protocol to welcome public mares on site.

Sent by email ahead of each cover booking, this document shall be compulsorily signed by both the boarding farm and the shipper, and returned to us by email before the cover.

THE SHIPPER & THE BOARDING FARM COMMIT TO STRICTLY COMPLY WITH THIS PROTOCOL. FAILING THAT, THE MARE WILL NOT BE COVERED.

All participants involved in this protocol must be in good health (absence of clinical signs and no abnormal temperature), are not contact people, nor ‘at-risk’ people.

DOCUMENTS TO SUPPLY IN CASE OF CONTROL BY THE AUTHORITIES

- Signed protocol
- Proof of professional activity (*Kbis extract, SIRET, SIREN, MSA declaration*) and/or employer’s certificate
- Transported horse’s shipping register (*available online from IFCE website*
<https://www.ifce.fr/ifce/sire-demarches/sanitaire-detention/registre-des-transports/>)
- Transported horse’s passport
- Driver ID
- Official derogatory certificate for displacement





AHEAD OF THE MARE'S TRANSPORT

- Cleansing and disinfection with virucidal agent of the transport vehicle just before shipping (on the day of transport).
- Compulsory appointment with the Haras ahead of the cover. In case of a difficult mare, the boarding farm must warn the Haras at the cover's booking
- Compulsory presence of hydro-alcoholic gel or solution onboard the vehicle
- Washing hands and/or wearing disposable gloves before loading the horse
- Moving the mare upon ovulation only, only one cover will be allowed per heat cycle to limit the transports
- If the mare is difficult or non-cooperative with the teaser and/or the stallion, the Haras reserves the right to refuse the cover
- Ensure to comply with the sanitary protocol by sending all required results to the Haras by email, at the latest on the day before the cover appointment
- Provide the Haras a copy of the mare's passport by email, including pages with mare's description and full vaccination history, in order to avoid any contamination by contact on the day of cover
- **Mares with a foal at foot : leave the foal at the boarding farm, do not bring the foal to the cover with the mare**
- Only one (1) person allowed in the horsebox to transport the mare to be covered, the driver must have taken note of this protocol
- **The owner and / or the boarding farm representative certifies that the mare has not been covered by another stallion**, without what new samples and lab tests results will be requested in compliance with the 2020 sanitary protocol
- **Except emergency cases linked with the transported horse, any stops on the way from the boarding farm to the Haras is strictly forbidden.**



UPON ARRIVAL AT HARAS DE BOUQUETOT

- The driver shall remain in his vehicle at all time and is strictly forbidden to leave his vehicle. Exchanges and communication shall be made by phone, the documents checked by interposed glass.
- The mare's ID check will be done from the email sent beforehand and the stallion man will establish a certificate of documents conformity and of cover (used later on to regularize the mare's passport) which will be addressed to the owner and / or the boarding farm by email after the cover.



IN CASE OF NON-COMPLIANCE OF THESE INSTRUCTIONS OR IN CASE OF DOUBTFUL COMPLIANCE, HARAS DE BOUQUETOT'S STALLIONS MANAGER MR BENOIT GIRRES (TEL +33 (0)6.45.04.86.80) RESERVES THE RIGHT TO REFUSE THE ACCESS OR THE COVER OF A MARE.
